## **Full University Professor and Chair in Human Genetics (W3)**

The professorship is associated with the directorship of the Institute of Human Genetics and the ambulatory health care centre. The professor represents the Institute in teaching, research and patient care.

The Institute of Human Genetics consists of subdivisions for Molecular Genetics, Genetic Epidemiology, Clinical Genetics, Cytogenetics and Tumorcytogenetics. Clinical and basic research focus areas are Tumor Genetics and Developmental Genetics/Syndromology.

We are seeking a person with an outstanding research profile. Criteria to evaluate the scientific reputation are success in grant applications, international standing and global visibility in the field of Human Genetics. The candidate is requested to present a concept for future research themes at the Institute of Human Genetics with an emphasis on embedding the four research foci of the medical faculty (cell differentiation, regeneration and neoplasia; vascular systems; neural systems; infection and inflammation). The Medical Faculty expects active collaborations with the existing collaborative research programs.

We are seeking a strong Institute leader revealing an integrative and cooperative personality. The position requires superior interdisciplinary and creative vision. The candidate needs to show motivation and abilities to build and maintain a strong team inside the Institute.

Candidates must have the license to practise medicine in Germany (Ärztliche Approbation) or fulfil the prerequisites for this license. Furthermore, the qualification in the field of Human Genetics of German „Facharzt“ or a qualification in the field of Human Genetics equivalent to German „Facharzt“ is necessary.

An innovative concept for teaching biomedical students at pregraduate and postgraduate levels will be evaluated.

Prerequisites for this position are scientific achievements gained within a junior professorship, habilitation or position as research scientist at a University/school of higher education or a non-University institution or in connection with an academic activity in business, industry, administration or other social area, either in Germany or abroad. Further prerequisites are stated in § 36 of legal regulations of the higher education act (Hochschulgesetz).

The University of Münster is an equal opportunity employer and is committed to increasing the proportion of women academics. Consequently, we actively encourage applications by women. Female candidates with equivalent qualifications and academic achievements will be preferentially considered within the framework of the legal possibilities. We also welcome applications from candidates with severe disabilities. Disabled candidates with equivalent qualifications will be preferentially considered.

According to a resolution by the Conference of the German Ministers for Science and Education of November 19, 1999, professors with clinical tasks will principally be employed on the basis of individually negotiable contracts (exceptions are possible, if applicants are already employed as life time professor of the salary group C<sub>4</sub>/C<sub>3</sub>/W<sub>3</sub>/W<sub>2</sub>). The clinical duties affiliated with this professorship will be laid down in a separate contract with the University Hospital.
